OFFICE ORDER

Sub: Payment of Ex-gratia for the year 2018-19.

It has been decided to pay an Ex-gratia amount equivalent to 30 days basic pay for the year 2018-19, as a "Special Incentive" for all MAHA-Metro Employees (Nagpur and Pune Metro Rail Project).

For the purpose of Ex-gratia payment, only Basic Pay in IDA Pay Scales, as on 31.03.2019 shall be taken into account. The employees drawing CDA pay scales shall be paid Ex-gratia on the basis of Basic Pay, as drawn on 31.03.2019.Other terms for payment of Ex-gratia shall be as under:-

- 1. The Ex- Gratia shall be calculated based on the actual basic pay drawn as on 31st March 2019.
- The employees who have worked during the entire year 2018-19(from 01st April 2018 to 31st March 2019) shall only be eligible for grant of Ex- Gratia for the year 2018-19.
- 3. The employees against whom the Major Penalty Charge-sheet is issued and/or Major Penalty has been imposed, as a result of D&AR proceedings during the financial year 2018- 19 or those who were prematurely repatriated(Depuationists) on account of unsatisfactory performance during the year are not eligible for payment of Ex- Gratia payment.
- 4. The Re-employed employees will be eligible for the payment of Ex- Gratia for the year 2018-19 taking 65% of the total consolidated fee as on 31.03.2019 as a Basic pay. Consultants directly working with MAHA-Metro(Appointed as Consultants on attaining 65 years) will also be eligible for the payment of Ex- Gratia for the year 2018- 19 taking their consolidated fee as Basic Pay.
- 5. Ex- Gratia will not be paid for the period an employee was on Leave Without Pay (LWP). For every LWP of 30 days for the total LWP for the year 2018- 19, Ex- Gratia equivalent to one month's entitlement will be deducted on pro- rata basis.
- 6. The payment of Ex-gratia will be made on the eve of "Diwali on 19.10.2019."
